TOWNSHIP REGULATIONS				
<ol> <li>No more than one (1) portable storage unit or dumpster per lot.</li> <li>A portable storage unit or dumpster shall be no larger than eight (8) feet wide, sixteen (16) feet long &amp; eight (8) feet high.</li> <li>No portable storage unit or dumpster can remain in a residential zoning district for more than fourteen (14) consecutive days or in excess of thirty (30) days in calendar year.</li> <li>No portable storage unit or dumpster can remain in a non-residential zoning disctrict for more than thirty (30) consecutive days or in excess of forty-five (45) days in any calendar year.</li> <li>A portable storage unit or dumpster shall be permitted during construction, alteration or renovation of the principal building and for an additional period of three (3) days before and after such activity, provided that a building permit has been issued by Ross Township. The portable storage unit or dumpster shall be removed from the lot before an Occupancy Permit is issued, or if the construction activity ceases for a period of more than seven (7) days.</li> </ol>
